**AGREED ORDER DIRECTING CLERK TO DEPOSIT INTERPLEAD FUNDS IN AN INTEREST-BEARING ACCOUNT**


On the undersigned day the Court considered the *Agreed Order Directing Clerk to Deposit Interplead Funds into an Interest Bearing Account* (the "Agreed Order") filed by Cantilo & Bennett, L.L.P., Special Deputy Receiver of Webb County Title & Abstract Company, Inc. (the "SDR" and "Webb County" respectively) and Intervenor/Interpleader, Glast, Phillips & Miller LLP. ("GPM"). Having considered the Agreed Order signed by counsel and the recommendation of the Special Master appointed in this proceeding, the Court finds that finds that, on or about October 17, 2008, GPM interplead \$62,557.92 into the registry of the Court for this receivership proceeding naming the SDR <sup>as GPM ac</sup> claimant to the funds and that the Clerk of the Court holds such funds in an account which does not pay interest. The Court further finds that the Intervenor and the SDR have agreed that the funds should be deposited into an interest bearing account and request that the Court direct the Clerk to so deposit the funds and maintain them in an interest bearing account pending further order by the Court regarding their disposition.

It is therefore ORDERED, ADJUDGED and DECREED as follows:

1. The Agreed Order is GRANTED in all respects.

2. The Clerk of the Court is ordered to deposit all funds interplead into the registry of the Court in this proceeding by GPM into an interest bearing account pending further order by the Court regarding their disposition..
